Our history

The company is founded in Lammhult (Sweden) by Ingvar Svensson. Household utensils are made of thermosetting polymer (bakelite) such as the lemon squeezer in the picture.

1960s The furniture industry is growing rapidly in the area around Lammhult. The first catalogue with our standard range is distributed.

We started manufacturing parts in thermoplastics. One of the first products was feet for the Pyramid chair.

ITAB (now Xano industri AB) buys Ackurat and becomes the first new company in a newly formed industrial group.

The factory in Lammhult is expanded with a completely new production hall.

The tool making workshop in new premises.

The range is expanded by purchasing a number of mould tools from Plastinject and Plast AB Orion in Anderstorp.

The first step outside of Sweden is taken by opening of a sales office in Helsinki (Finland).

Ackurat is introducing its own traveling product specialists.

The range greatly increases through the purchase of a large number of mould tools from Plastunion.

International cooperation begins when an agreement is concluded with a German company.

Brand new and fresh office building is built in Lammhult.

Ackurat exhibits at the Stockholm Furniture Fair for the first time.

We introducing vibration welding of felt on furniture feet. First in the World.

All products are presented on the internet, and our e-commerce starts.

A new high bay warehouse is built in Lammhult.

 Ackurat exhibits at Furnica in Poznan (Poland) for the first time. A strategic decision to work without intermediaries in all of Europe is taken.

The first agreements with furniture manufacturers in the UK.

A sales office is opened in Gdansk (Poland).

Regular presence of product specialists outside of Sweden begins.

Ackurat exhibits at Euroshop in Düsseldorf (Germany) for the first time.

2008 Injection moulding machines are connected digitally.

Warehouse and some manufacturing introduced in Gdansk.

The factory is optimised for a more order driven manufacturing using LEAN.

Ackurat exhibits in Milan (Italy) for the first time.

Ackurat exhibits at Interzum in Cologne (Germany) for the first time.

A strategic decision is made to increase investment in development of unique products.

The business system is replaced to better suit global trade and a digitalised industry.

The first standard products in bioplastics presented.

A charging station for electric cars is installed in Lammhult.

 Ackurat was contacted by product developer Alvar Lundgren. It resulted in Ackurat taking over a patent for a product for joining boards. The solution was developed into the product Clixtag, which became Ackurat's first patented product.

Ackurat decides to gradually phase out common plastics in favor of bioplastics.

Ackurat was contacted by aircraft technician Anders Johansson. We ended up buying a piece of equipment from him, for compression moulding of felt caps (XCF).

Exhibiting for the first time at the Design District in Rotterdam, the Netherlands, after two years of tough restrictions due to the pandemic.
